2. <u>Sweepstakes Description and Timing</u>: The Sweepstakes entry period begins on or before May 1, 2018 at 11:00 AM (Pacific Time (U.S.)) and ends on May 31, 2018 at 11:00 AM (Pacific Time (U.S.)) (the "Sweepstakes Term"). Sponsor will randomly select the prize winners in accordance with the timing described in Section 5 below, drawn from all eligible entries to receive the prizes, as described in these Official Rules.

3. <u>Eligibility</u>: Except for the jurisdictions excluded below, this Sweepstakes is open to legal residents of the United States of America who are 21 (twenty-one) years old or older at the time of entry and who can provide proof of U.S. residency. **EXCLUDED JURISDICTIONS:** Residents of California, Colorado, Connecticut, Florida, Hawaii, Illinois, Maryland, Massachusetts, New Jersey, New York, and the District of Columbia are excluded from this Sweepstakes and are ineligible to participate. Upon submission of a Direct Entry, entrants will receive a confirmation screen, with a unique link to provide to other potential entrants. Entrants will receive one (1) additional entry into the Sweepstakes drawing each time the unique link is utilized by a separate entrant to enter the Sweepstakes ("Indirect Entries"), up to a limit of one hundred (100) additional Indirect Entries. Indirect Entries shall be associated with the originating entrant's Direct Entry into the Sweepstakes. Automated or robotic entries submitted by individuals or organizations will be disqualified. Except as provided herein, any attempt by an entrant to enter more than once by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void that entrant's entries and that entrant may be disgualified.
